<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 28/11/23 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please can you indicate which Primary Care Networks within your organisation has full identifiable or anonymised Data Sharing Agreements in place between their membership GP practices? Can you also indicate if your PCN's use EMIS Enterprise?

Our Response

In accordance with Section 1 of the FOIA NENC ICB can not provide this information as it is not held by the ICB. PCN's are a network of GP practices and are not legal entities. However, it is likely that individual GP practices hold this information you may wish to redirect your request to them.
