Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 2 August 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

- 1) When did CHC start charging for a disabled persons travel costs in fully funded care? And how are they invoiced?
- 2) Do CHC have authority to take DWP PIP Mobility to pay towards fully funded care? If yes, how is this managed/arranged?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

- 1. CHC do not invoice any service user for their care. Each case is considered on a case-by-case basis and all available options of support are considered when determining a bespoke care plan. CHC is not means tested and all identified care needs in the care plan will be funded via
- 2. DWP PIP payments are payable to meet the travel arrangements for an individual following assessment by DWP. CHC payments are there to cover the costs of care needs as detailed in the response to question 1.
