<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 05 April 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the freedom of information act 2000, I'm requesting the following information:

Please could you provide a copy of the most recent draft of NHS North East and North Cumbria ICB's Joint Forward Plan? According to <u>guidance from NHS England</u> these were due to be drafted for consultation as of 31 March 2023 (pg 2).

Our Response

NHS North East and North Cumbria ICB can confirm that they hold the information in scope of your request however it is exempt from disclosure because it is intended for future publication.

NHS North East and North Cumbria ICB is not obliged to provide information that is intended for future publication (section 22 of the Act) as this information will be published by 30th June on the ICB's website https://northeastnorthcumbria.nhs.uk/

At present the document is an internal working draft document and will be shared in public once finalised in line with the NHS England timescales. A final draft will be presented to the ICB Board. Papers for this meeting are also published on the website 7 days in advance of the meeting.

As section 22 is a 'qualified exemption', it requires NHS North East and North Cumbria ICB to demonstrate the prejudice which would occur if the information were to be released, and to consider whether the public interest is in favour of releasing the information regardless. When assessing whether or not it was in the public interest to disclose the information to you, NHS North East and North Cumbria took into account the following factors:

Public interest considerations favouring disclosure

- Disclosure FOIA would be consistent with the government's commitment to transparency
- Transparency of functions and services to NHS
- Encourage and instil trust and confidence
- The disclosure would not bear any threat to the protection of the public

Public interest considerations favouring withholding the information

- Future publication is the most cost-effective way of releasing information
- The report is prepared for NHS England. It would therefore not be in the public interest for the report to be disclosed in advance of it being shared with the body for which it was commissioned.
- The report and its contents are not yet finalised, and it is not in the public interest to provide an interim version which could provide inaccurate information. Such disclosure would not promote credibility or trust
- The information is due to be made public given its value and interest to a wide audience. It is not in the public interest to disclose such information to a small number of individuals in advance of wider publication
- It is in the public interest to ensure that the information is available to all members of the public at the same time; premature publication could undermine the principle of making the information available to all at the same time through the official publication process.
- Early release of the information in response to a FoI request could put unnecessary
 pressure on the ICB to publish earlier than planned, potentially resulting in reduced
 quality of the final data. This is clearly not in the public interest as it negatively
 impacts on the ICB's ability to publish information in a co-ordinated and considered
 fashion. The ICB want the public to have confidence in the information and data it
 publishes.

Having undertaken the balancing exercise, NHS North East and North Cumbria ICB has concluded that the public interest in maintaining the exemption outweighs the public interest in disclosing the requested information and that given the necessary preparation and administration involved in publishing the information, which includes liaison with other organisations, and collation of information, the ICB consider that our publication timetable is reasonable.

Generally, the Information Commissioner cannot make a decision unless you have exhausted the complaints procedure provided by the North of England Commissioning Support Unit.
