Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 7 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

This FOI request is linked to FOI ICB 24-283. Just to ensure my understanding is correct, could you please clarify the below keeping the same numbering?

- 1. In the original response, it is noted that "children are included in the specification from Eden Valley Hospice that also includes adults". Currently, only the NHSE children and young people service specification has been provided. Could you please provide a copy of the service specification specific to Eden Valley Hospice?
- 2. Is it correct to say that work is currently underway in the ICB to update the existing EVH service specification to reflect the NHSE service specification mentioned above and provided in the original response?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.
