## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and</u> <u>North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 17 August 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

- Please provide the number of North East Ambulance Service (NEAS) weekly nonurgent patient transport jobs operated out of South Tees Hospitals NHS Foundation Trust averaged for the financial year 2023/24.
- 2. Please provide the total number of NEAS non-urgent patient transport jobs, broken down by month operated out of South Tees Hospitals NHS Foundation Trust over the financial year 2022/23.
- 3. How are these NEAS jobs funded and paid for?

- 4. Have there been any customer satisfaction feedback for NEAS jobs operated from South Tees NHS Foundation Trust? If so, how many?
- 5. Have there been any customer complaints fed back for NEAS jobs operated from South Tees NHS Foundation Trust? If so, how many?
- 6. Has NEAS operated any non-urgent same day patient transport requests from South Tees NHS Foundation Trust in the financial year 2023/24? If so, how many?

## **Our Response**

NENC ICB does not hold the requested information. NEAS provides pre-planned nonemergency transport for patients. Therefore, we suggest that you redirect your request to them at <u>publicrelations@neas.nhs.uk</u>
