Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 6 December 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act, I would like to request the following information:

1. Has the Primary Care Transformation budget allocated to your ICB as outlined in Appendix 1 of the attached document changed?
2. If so, what is the new figure?
3. If the figure has not changed, will you change it and what will the new figure be?

For the purpose of this FOI, I have attached NHS England's Primary care service development funding and general practice IT funding guidance 2024/25 document. In the document you will find the heading: Appendix 1: ICB primary care SDF allocations. In the Appendix it outlines the Primary Care Transformation budget allocated to each individual ICB.
