## <u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board (ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 01 December 2022 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

## **Details of Your Request**

I would like a copy of the pathology network maturity self-assessment tool compiled for "North Cumbria Pathology Network (North 1)" and sent to NHS England in 2022. This was a standardised matrix built by NHSE and sent out to all pathology networks to fill in and send back.
