<u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 30 November 2022 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows;

Request

I am writing to you under the Freedom of Information Act 2000 to request the following information from North East and North Cumbria ICB Perinatal Mental Health Team.

I'm interested in data held between 2020 and the present day.

Please can you tell me:

- 1. The number of patients referred or self-referred to the service and accepted for treatment, broken down by year
- 2. The number of patients referred or self-referred to the service and rejected, broken down by year.
- 3. A list of the reasons patients were rejected from the service, by year, broken down by proportion.
- 4. The number of appointments per year held by phone, online and in person broken down by type.
- 5. The average waiting time for a patient between referral and first appointment, broken down by year.
