## <u>Freedom of Information Act 2000 - Request for Information – NHS North East &</u> <u>North Cumbria Integrated Care Board (ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 04 July 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

## **Details of Request**

As a patient with an inherited cardiac condition (hypertrophic cardiomyopathy) I would like to establish what centres within the ICS would I be under the care of? I.e., what hospitals have a dedicated inherited cardiac conditions team. If they do not have a dedicated team or would not treat the condition where would patients be referred to? Specifically, would a local hospital manage drug treatment up until the stage of surgery (septal ablation or surgical myectomy)? If surgery is not offered where would the patient be referred to?
