Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your Freedom of Information (FOI) request received by the North East and the North Cumbria Integrated Care Board (NENC ICB) on 30 January 2024.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up - Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland, and Stockton-on-Tees).

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

Details of Request and Response

Purchase of bed capacity in the private mental health sector:


We would like to know the following information for the past 5 calendar years (please break this down into 2019, 2020 etc).

- 1. The total contracted spend on private in-patient mental health beds by the ICB.
- 2. The breakdown of the contracted spend on private in-patient mental health beds by the ICB (how much has been spent on CAMHS, older adult, PICU, general adult etc).
- 3. The total non-contracted/ ad-hoc/ unplanned spend on private in-patient mental health beds by
- 4. The breakdown of the non-contracted/ ad-hoc/ unplanned spend on private in-patient mental health beds by the ICB.

Total forecast spend on in-patient mental health beds in 2023/24 is £5.3m, although that represents all non-NHS spend and may include some care provided for people with Learning Disabilities or Autism. This covers both contracted and non-contracted spend on inpatient care.

We don't have any specific block contract arrangements with any providers for this care but would put in place an individual agreement for each patient who is placed with a provider. The breakdown across the areas indicated is:
