**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 27 November 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

I am writing to make a request for information under the Freedom of Information Act 2000.

Please provide the following information for all Primary Care Networks (PCNs) within the North East and North Cumbria Integrated Care Board (NENC ICB) area for the financial years 2024/25 and 2025/26 (to current date):

1. A list of PCNs that have overspent or underspent on their Additional Roles Reimbursement Scheme (ARRS) budgets.
2. For each PCN identified, please provide:
  - a. The total ARRS budget allocation for the relevant financial year;
  - b. The total expenditure incurred;
  - c. Whether the PCN overspent or underspent; and
  - d. The amount by which the budget was exceeded or underspent.
3. Please also provide any available explanation or clarification regarding:
  - a. How overspends have occurred, given that I believe the ARRS payments are drawn down to cover actual salary costs and budgets are capped in line with national funding limits; and

b. The factors contributing to any underspends (for example, recruitment delays, unfilled posts, or other operational issues).

If available, please provide the information in a tabular format (for example, Excel or CSV). I would be grateful if you could acknowledge receipt of this request and provide your response within the statutory 20 working days.
