## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 07 February 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

I am currently working within a research team investigating the referral pathways between primary and secondary care, specifically for diabetic patients who are at moderate to high risk of developing lower limb diabetic complications. How can I please access these guidelines?

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

NENC ICB has liaised with the Clinical lead for Diabetes footcare and they have responded as follows:

I think perhaps the requester is asking for is the JCUH Diabetes Foot Referral Pathway which is attached. While this is the South Tees pathway, this document was produced by the NENC foot care network so all trusts in NENC have a pathway that looks very similar to this.
