### <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 3 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

I would like to request the following information about mental health support for children and young people aged 11 to 25 in North East and North Cumbria under the Freedom of Information Act.

- 1. Which NHS trusts provide CAMHS?
- 2. Which CAMHS services are offered? Please list these services.
- 3. Do you operate a 0-25 service?
- 4. Can young people self-refer to CAMHS?
- 5. Which of the following non-specialist publicly funded services for young people's mental health (a) currently exist and/or (b) used to exist within the last decade (please indicate if they currently exist, and if they used to exist if you hold this data):
  - a. Social prescribing
  - b. Bereavement services
  - c. Peer support
  - d. Mental Health Support Teams
  - e. School counsellors, mentors, or pastoral or key support workers
  - f. Educational psychologists
  - g. Youth groups

# **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

In response to your question 1, the trusts providing CAMHS services within the North East and North Cumbria ICB region are Northumbria Healthcare NHS Foundation Trust (FT), Cumbria, Northumberland, Tyne & Wear NHS FT and Tees, Esk & Wear Valley NHS FT.

In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for questions 2 to 12.

The North East and North Cumbria Integrated Care Board (NENC ICB) does not hold the records which you have sought. However, we have determined the records are held by Acute and Mental Health Hospital NHS Foundation Trusts within the North East and North Cumbria region.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those hospitals who provide CAMHS to make your request.
