### <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 7 November 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

Pursuant to the principles of the Freedom of Information Act (FOIA), I am writing to request information regarding referral management and expenditure of the ICB within the periods April 2024 to October 2024.

Within the defined time periods, can you please confirm:

- 1. Does the ICB have an independent third-party referral management centre?
  - a. If the answer is "Yes" to the above, please indicate by month the number of ophthalmology referrals shared with providers broken down by month and provider.
- 2. Has the ICB commissioned an independent e-ERS for the processing of ophthalmology referrals?
  - a. If the answer is "Yes" to the above, please indicate by month the number of ophthalmology referrals shared with providers broken down by month and provider.
- 3. Can the ICB provide all expenditure to the following providers, broken down by month and HRG, or cumulatively where HRG descriptors are unavailable:

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

- 1. The ICB does not have independent third-party referral management centres. EyeV is a referral platform allowing electronic eye care referrals, from Primary care to secondary care, the Newcastle upon Tyne Hospitals NHS Foundation Trust (NuTH) triages referrals. There is no referral management centre.
- 2. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

The ICB have commissioned EyeV to process e-ERS ophthalmology referrals however the data sits with NuTH and EyeV.

3. Expenditure is detailed on the attached spreadsheet.
