<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 9 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

You previously confirmed having a Local Enhanced Services (LES) or Directed Enhanced Service (DES) in place for Primary Care related to wound care. Regarding this in each place:

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

County Durham place

- 1. There is a LES/DES in place. Payment is part of a block payment and inclusion and inclusion and exclusion criteria is not itemised.
- 2. Please refer to the response to question 1. Practices undertake the services listed below.
 - Wound care.
 - Suture/Clip removal.
 - Swab/Wound care (excluding for sexual health services).
 - Initial and follow up wound dressings, suture removal & prescribing.
 - Administration of LMWH as recommended by secondary care.
 - Leg ulcer treatment.
 - Compression bandaging.
 - 2- and 4-Layer Dressings (working with acute trust specialist nurses).
- 3. Please refer to the responses to question 1 and question 2.
- 4. Please refer to the responses to question 1 and question 2.

Newcastle Gateshead, Northumberland and North Tyneside places

- 1. No, the LES/DES does not include postoperative wound management.
- 2. No, the LES/DES does not include traumatic wounds e.g. trauma and skin tears.
- 3. No, the LES/DES does not include complex wound care.
- 4. No, the LES/DES does not include pressure ulcer prevention or pressure ulcer wound care.

North Cumbria and South Tyneside and Sunderland places

These ICB place does not have any LES or DES contracts for wound care.

Tees Valley place

Tees Valley place of NENC ICB commission GP practices via a Primary care Local Improvement (LIS) to undertake services which are considered to be 'outside of core GMS'.

The service is available to patients who are permanently or temporarily registered with a GP practice in the geographical boundaries of: Darlington, Hartlepool, Stockton-on-Tees, Middlesbrough and Redcar and Cleveland. Practices are commissioned to ensure all patients

registered with their practice can access all the services listed in the LIS, during core hours and enhanced access hours.

The LIS covers a number of enhanced treatments, these treatments are those historically delivered by practices as part of Practice Enhanced Treatment Service (PETS) schemes or Enabling Services which may have previously been contracted via an NHS Standard Contract but were incorporated into the LIS in 2019/20.

It is recognised that the services/procedures being undertaken will vary, depending on the needs of the patients presenting at each practice and the skills/competencies of staff within each practice. The enhanced treatments include the following in relation to wound care:

- Initial and follow up wound dressings.
- Leg ulcer treatment.
- Compression bandaging.
- 2- and 4-layer dressing.
- Doppler Assessment/ABPI (excluding diabetes foot checks).
- Suture/clip removal.
- Swab/wound care (excluding sexual health services).

Enhanced treatments are part of chapter 1 within the LIS, if practices achieve all elements in chapter 1, they are paid monthly a cost of £7.08 per patient. Payment is not based on individual activity.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website https://northeastnorthcumbria.nhs.uk/.
