## Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 12 February 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

Please would you be kind enough to provide me with the referral pathways for the following:

- 1. ADHD for children to CAMHS/NHS services/local authority services
- 2. ADHD for children to right to choose providers
- 3. ASD for children to CAMHS/NHS services/local authority services
- 4. ASD for children to right to choose providers
- 5. ADHD for adults to NHS services
- 6. ADHD for adults to right to choose providers
- 7. ASD for adults to NHS services
- 8. ASD for adult to right to choose providers

I would like to know any policies and protocols that the ICB has for ADHD and ASD which are communicated to GPs, CAMHS and schools. Including any regarding shared care for ADHD medication

## **Our Response**









We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

Thank you for your Freedom of Information (FOI) request regarding referral pathways for ADHD and ASD services covering North Cumbria, Newcastle, Gateshead, North Tyneside, Northumberland, South Tyneside, Sunderland, Durham and Tees Valley Integrated Care Board (ICB) places.

Access to NHS providers and Right to Choose providers for ADHD and ASD assessments and treatment is via a GP referral through primary care. This applies to both children and adults seeking diagnosis and / or treatment. The specific provider and pathway may depend on local commissioning arrangements and eligibility under the Right to Choose framework.

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information for referrals made via Special Educational Needs and Disabilities (SEND) and Local Authority routes to access local authority services. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

For referrals made via SEND and Local Authority routes to access local authority services, we would recommend that you contact NENC Local Authority individually for their specific criteria and pathways.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those local authorities to make your request.
