<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 26 January 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

The team I work with are looking at Neuro services across the England. Specifically, we wanted to review the current waiting list and referral data (e.g., date from when a young person is referred to being seen for assessment/treatment) for services across different parts of the country.

Please can you tell us the current waiting times for young people being assessed for attention deficit hyperactivity disorder within your local area, e.g., when a young person is referred and how long it will take for them to be seen for an assessment/treatment.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold some of the requested information.

County Durham and Tees Valley places

The attached information applies to County Durham and Tees Valley Children and Young People only (up to the age of 18) for the period up to 2nd January 2024. Reports are provided routinely by Tees, Esk and Wear Valleys NHS Foundation Trust to the NENC ICB. North Cumbria place

North Tyneside place

Please note that the wait times and numbers for North Tyneside are for a full neurodevelopmental assessment and are not ADHD specific as the CAMHS service reports on neuro as a whole.

As of 15th January 2024, there were 520 patients on the Neuro Waiting List.
