<u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 12 December 2022 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Request

Does the ICB for your area have a workforce strategic plan that includes investment in occupational health and wellbeing to support NHS staff retention in primary, community and secondary care?

Response

We are in the process of developing our workforce strategy for the ICB and have 3 planning dates with the system, HEE and NHSE colleagues to develop our plans.

In terms of well-being we are working as a region to support a well-being strategy.
