Report Title:	Updated Governance Handbook (Issue 8)				

Purpose of report

To request approval from the Board on the proposed amendments to the ICB's Governance Handbook including the Scheme of Reservation and Delegation, committee terms of reference and the ICB committee structure.

The Board is also asked to note the updated terms of reference for the subcommittees of the Executive and Quality and Safety Committees.

Key points

NHS North East and North Cumbria Integrated Care Board (the ICB) is the statutory decision-making body of the North East and North Cumbria Integrated Care System. The ICB is responsible for the commissioning of health services and effective stewardship of NHS spending for all the people living in the North East and North Cumbria (NENC).

The ICB's Constitution and supporting documents create the framework for the ICB to delegate decision-making authority, functions, and resources to ensure it meets the diverse needs of our citizens and communities. The Constitution sets out the functions that the ICB will undertake and is supported by the governance handbook.

The handbook includes several key documents including a functions and decisions map, scheme of reservation and delegation, financial limits, and committee terms of reference. The documents have previously been approved by the Board with subsequent issues for further amendment from (issue 1) approved on 1 July 2022 to the current (issue 8) to seek approval at by the Board in line with the new changes.

As part of a process of ongoing review of the documents within the Governance Handbook, further amendments have been identified to ensure the documents remain fit for purpose. The amended documents are attached with changes highlighted or tracked and summarised below:

Changes to the Scheme of Reservation and Delegation (SoRD)

Individual Funding Requests (IFR), page 16 - clarification within the supporting notes section
concerning requests that fall within the scope of the policy and the financial considerations of
decisions.

Annual Review of Committee Terms of Reference

The terms of reference for the five ICB committees (Audit Committee, Remuneration Committee, Executive Committee, Quality and Safety Committee, and Finance, Performance and Investment Committee) have been reviewed and aligned to the revised standard template for ICB committees. In addition, some minor changes have been made to the wording within the terms of reference following review of all ICB committee terms of reference to ensure consistency of language throughout.

Alongside the minor changes noted above, some changes to job titles of members on the Committees have been amended which will come into effect in April on the implementation of the ICB's updated structures following the ICB 2.0 process. The Quality and Safety Committee has asked that the terms of reference are considered further by the Committee members to explore whether the purpose and responsibilities of the Committee remain appropriate. Any further resulting changes will be brought back to Board for approval at a future meeting. In the interim the current terms of reference have been transferred to the updated ICB template pending further changes.
