Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received on 9 April 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to request information under the Freedom of Information Act 2000. I am requesting the following information in respect of Diabetes (SMBG test strips, Continuous Glucose monitoring (CGM) systems). For each area:

1. The name(s) and direct contact email address(es) and direct telephone numbers of the person(s) who are responsible for the formulary
2. The date of the next review of your formulary
3. Details of how you intend to review your formulary (include process, timelines)
4. Details if part of a local partnership arrangement for formulary review. Please provide the contact's name, email address and telephone number for the person with responsibility where a partnership arrangement is in place.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

1. Formulary responsibility is with Northern Treatment Advisory Group (NTAG). Contact is via nuth.nyrdtc.rxsupp@nhs.net

2. Formulary choices of BGM will be reviewed in February 2027 along with the self-monitoring guidelines. [NENC-Guidelines-Self-Monitoring-of-Blood-Glucose-and-ketones-in-Diabetes-update-Jan-2025-approved.pdf](#)
3. The intended review process has not yet been decided.
4. The self-monitoring guidelines were developed following consultation with diabetes secondary care and primary care specialists as well as NHSE guidance and lead by the NENC ICB Medicines Optimisation team diabetes portfolio group. Contact for this group is via nencicb-sun.mo@nhs.net
