# <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 3 August 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

#### Your Request

I am writing to you under the Freedom of Information Act 2000 to request information on the commissioning of ear wax removal services by North East and North Cumbria integrated care board. Please may you provide me with answers to the questions below.

- 1. Does the integrated care board currently commission an ear wax removal service or services within primary care or community ear care services, available to <u>all</u> patients registered with GP practices within the ICS's boundary, as per <u>NICE guidance</u>?
- 2. If it does, how can a patient access this service or services when it is considered clinically necessary and/or self-care advice, if appropriate, has been unsuccessful?
- 3. If the integrated care board does commission this service or services within primary care or community ear care services, please provide the name or names of those commissioned providers and their address or addresses.
- 4. Does the integrated care board have a policy or guidance on ear wax removal and/or referral pathways for its primary care providers for patients for whom the benefit of ear wax removal is clinically indicated?
- 5. If the integrated care board has issued such guidance, please provide a copy.

### **Our Response**

## County Durham place

- 1. Durham has a Local Improvement & Integration scheme (LIAISE) and one of the requirements in the block element of this contract is Ear Care as below. Ear Care, in line with NICE Guidance. Practices must demonstrate that they are offering in house Aural irrigation, where this is indicated. Some PCN areas are looking to set up PCN level Ear Care services. All Practices have confirmed they offer ear care where required in line with NICE guidance.

- 1. A Community Ear Wax Service is provided by North Cumbria Integrated Care NHS FT for patients that live within or are registered permanently or temporarily at a GP practice that is within North Cumbria.
- 2. Patients can be referred to the Community Ear Wax service via ICE electronic referral system.
- 3. The commissioned provider name and address is North Cumbria Integrated Care NHS FT, Trust Headquarters, Pillars Building, Cumberland Infirmary, Infirmary Street, Carlisle, CA2 7HY.
