<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 5 April 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

- 1. How many Lone Worker device/solution contracts does the ICS and its affiliate Trusts have in place? Please specify contract details.
- 2. How many staff within each of the ICS' Trusts are eligible to have a Lone Worker solution?
- 3. How many staff within each Trust actually have a Lone Worker solution allocated to them?
- 4. When are the contract dates for renewal of each of the above contracts?

Our Response

In relation to your question 1, North East and North Cumbria ICB does not hold a lone worker solution contract and has not identified a need for this.
