<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 15 November 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing in relation to news that the Government has refused requests from NHS England to allocate £1 billion to address the financial impact on NHS budgets from industrial action, and that NHSE has now told finance directors that c. £600m from the previously ringfenced "service development fund" for several improvement initiatives can be repurposed to support their financial plans.

Under the Freedom of Information Act regulations, I would like to request the following information:

1. Please advise:

i) What is your budget for dentistry this financial year?

- ii) How much has been spent as of 8th November 2023;
- iii) What is your estimated underspend in dentistry this year; and
- iv) How much, if any, of this will be made available to support your financial plans?
- 2. What assessment you have made of the impact these budget reallocations will have on patients and services?

Please do not hesitate to contact me should any aspect of my request require clarification.

Our Response

- 1. Question 1 responses:
 - i. The total dental budget for the 2023/24 financial year is £216,822k.
 - ii. Year to date costs against the dental budget for the 7 months to 31st October 2023 were £126.479k.
 - iii. The latest forecast underspend on dental budgets this year is approximately £16.4m. This is an estimate and will continue to be reviewed over the remainder of the year with investment plans agreed to support dental access recovery.
 - iv. Any remaining underspend on dental budgets will support the overall delivery of ICB financial plans.
- 2. The initial quality impact assessment is that there is no additional adverse impact on patients and services as the forecast underspend is due to lack of providers rather than a cut in provision by the ICB the ICB has invested additional resource of around £3m to increase capacity wherever possible whilst developing longer term solutions to service gaps.
