Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 18 December 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act I am requesting the following information:

- 1. The ICB's cost improvement programme (CIP) for the financial year 2023/24. Please break this down by each category eg. 'Recurrent', 'non-recurrent', 'pay', 'non-pay' and 'other'. Please also detail how much of the total savings were identified and how much were non-identified
 - a. Please provide the name of each scheme where the savings were to come from and how much you expected it to save. Eq 'establishment review', 'corporate services' 'transformation', 'service redesign'.
 - b. For each scheme, please provide a sentence or two to explain what it consisted of and how much it was expected to save. Eg, for service redesign - a reduction in length of stay or a skills mix review to ensure patients are being treated by the correct profession. For pay, this may be redundancies.
 - c. Please provide a full year breakdown of the trust's actual savings against the targets set out above
- 2. Please provide the trust's CIP plan for 2024/25 and include a breakdown of all the relevant categories, schemes and savings targets as set out above.
