<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 23 May 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

- 1. Yes, a contractual agreement is in place for supply of services from Kooth Digital Health Limited based at 5 Merchant Square, London, England, W2 1AY?
 - The agreement is due to end 31 March 2026.
 - Contracts were originally let through the Direct Award process under the Public Contracts Regulations 2015. The contracts were awarded directly and were not advertised.
 - There is no extension clause in the contract.
 - No decision been made on whether the contract is being either extended or renewed.
 - Senior officers (outside of procurement) responsible for this contract are Jane Walker and Sarah Dean-Golightly.
 - The contract was awarded through Direct Award Process C of the Provider Selection Regime. There was no invitation to tender.
- 2. There is no contractual agreement in place for supply of services from Tellmi (also known as MeeToo Education Ltd) based at 1 Royal Street, London, SE1 7LL?
- 3. There is no contractual agreement in place for supply of services from Togetherall Ltd based at 27 Old Gloucester Street, London, England, WC1N 3AX?
