Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 09 February 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up - Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

Your Request

Please can you provide me with a list of low secure units that accept patients currently detained under the Mental Health Act 1983 (as amended by the 2007 Act) who have a diagnosis of a Personality Disorder and a clinical likely diagnosis of Autism Spectrum Disorder. It would also be helpful if they could address neurodevelopmental difficulties and deliver the Good Lives Programme (risk programme for patients not necessarily accepting of the sexual offence).


Our Response
