Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received on 26 February 2026 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

2. For each contracted provider listed in the answer to #1, please provide the following schedules as included in the contract the ICB holds:
 - Schedule 2A or equivalent: Service Specification that describes the service (whether standalone or integrated in a broader Service Specification)
 - Schedule 3A, 3B or 3C or equivalents: Describing national currencies and any local prices that apply to the services
