Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 29 December 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Recently, Voltorol 50mg suppositories have been reclassified as a 'red drug.' I'd like to request the following:

- 1. Any impact assessments made on what this will do to patients who had this particular drug perceived them.
- 2. Any information on procedures for contacting patients in advance of this decision so they could be better prepared on how to deal with this event.
- 3. Whether advice was provided and/or followed by practices.
- 4. How many people did this decision impact, just raw numbers please.
- 5. Who (either collectively or individually) signed off this decision which has impacted all the above people.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

Voltarol suppositories, listed under the generic name Diclofenac, have always been classed as RED on the NENC ICB formulary. North East and North Cumbria Formulary.

Previous to the NENC ICB formulary, Voltarol Suppositories have historically been red classification or no classification in areas of ICB. Historically:

- North of Tyne, Gateshead and North Cumbria (NoTGNC) formulary In NoTGNC, diclofenac suppositories were not on the formulary and diclofenac use was generally restricted for post-op pain. Long term use was 4th line after ibuprofen and naproxen (low and high dose)
- South Tyneside and Sunderland Diclofenac suppositories were not listed.
- County Durham and Tees Valley listed as RED. All oral forms of diclofenac were removed when the Tees and Durham formularies were merged in the summer of 2019 as not the preferred NSAID on the grounds of safety. The suppositories were made RED at the same time as led to believe largely only used post-op.
- Mar 2023, Northern Treatment Advisory Group (NTAG) a comparison of the three APC formularies with a proposed status in new single ICB formulary came to NTAG following meetings of formulary pharmacists across NENC who reviewed each BNF chapter. This included proposal that diclofenac suppositories be classified as RED based on previous historical status. This RAG list alignment was consulted on via NTAG website for 4 weeks in June 2023 and no comments received regarding diclofenac suppositories being RED.
- **July 2023** Formulary signed off by the Clinical Director post public and clinical consultation as outlined above.
- Nov 2023 Formulary Working Group (FWG) recommendations:
 - Diclofenac suppositories for renal colic Request to change the status of diclofenac suppositories to GREEN PLUS for renal colic as there had been some requests to continue this in primary care from urology. The group felt that overall, this wasn't required. Minutes available at <u>AGENDA ITEM 2</u> No comments were received on during the public consultation that followed in Nov 2023. FWG recommendations came to NTAG in Jan 2024 and were approved by Medicines Subcommittee in Feb 2024 and the category remained Red.
 - Decision summary NENC medicines committee February 2024: <u>NENC-Medicines-Committee-decision-summary-February-2024-final-v2.1.pdf</u> It states: *Diclofenac suppositories for renal colic; To remain RED following a request to change the status of diclofenac suppositories to GREEN PLUS for renal colic as there had been some requests to continue this in primary care from urology. The group felt that overall a change on RAG status was not required.*

- 1. As Voltarol suppositories were classed as prescription by a specialist only i.e RED, no impact assessments were made in primary care. They were considered unnecessary as there was no change in status made.
- 2. No consideration was given to contacting patients as no changes to status was made.
- 3. The formulary is available to practices and reflected in electronic prescribing systems used in GP practices. All decisions made by Medicines Committee are made available at: <u>Decision Summaries NTAG</u> and prescribers are informed of updates on each occasion. No specific advice was provided to practices on this occasion as no changes were made and advice remained that diclofenac suppositories should only be prescribed by specialists.
- 4. The decision should not have affected any patients as no change was made to formulary and guidance.
- 5. Minutes of the NENC Medicines Committee meeting at which the decision not to change status was agreed as per recommendations of Formulary Working Group <u>AGENDA ITEM 2</u> is available at: <u>NTAG-Minutes-January-2024-approved.pdf</u>. Membership of both groups is recorded in their respective minutes.
