Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 10 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Please provide the following information:

1. The ICB's Elective Recovery Funding (ERF) % target for 24/25.
2. The year-to-date performance against the ICB ERF % Target for 24/25. Please advise which month the year-to-date performance relates to.
3. Please provide for each Trust within the ICB their individual ERF % target for 24/25.
4. Please provide for each Trust within the ICB their performance year to date against their individual ERF % target for 24/25. Please advise which month the year-to-date performance.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

1. The ICB's Elective Recovery Funding (ERF) % Target for 2024/25 is 108.88%.
2. No national performance data against the ICB ERF targets is yet available for 2024/25.

3. Please find acute trust ERF targets for 2024/25 in the table below. Targets are subject to change following publication of final 2023/24 outturn achievement, and impact of SDEC coding changes.
