Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received on 18 November 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act, I would like to request the following information request concerning the procurement of your Integrated Urgent Care services. Could you kindly supply the following information:

1. What is the name of the organisation(s) currently providing Integrated Urgent Care (IUC) services for your ICB, including:
 - a. NHS111
 - b. Clinical Assessment Service (CAS)
 - c. GP Out of Hours (OOHs)
2. When were the contract start dates for your above named IUC contracts?
3. What is the duration of the current initial contract term per contract? If contracts include extension clauses, please advise on the duration & frequency.
4. When are the current IUC contracts due to expire? (Including any extension periods which have been confirmed or utilised)
5. What is the estimated total annual contract value or budget allocated for each of your current or future IUC contracts named above?
6. Does the ICB have an anticipated timeline for the procurement of future IUC contracts? If so, please share details.

7. Does the ICB intend to commission future IUC service components (NHS111, CAS & OOHs) separately or together? If separately, please advise on how you will/might separate the lots?
8. Does the ICB intend to introduce additional services or expand the scope compared with the current IUC contract provision?
9. Do your existing IUC providers utilise AI triage within service delivery? If yes, which models are deployed?
10. For future IUC procurements, does the ICB intend to mandate AI triage & if so, is there a specific AI triage model which would be preferred or mandated?
11. Can the ICB confirm which procurement process they intend to use for future IUC procurements (e.g. competitive process, Provider Selection Regime (PSR) regulation)
12. Has the ICB conducted (or intend to conduct) any market engagement exercises or Prior Information Notices (PIN) regarding future IUC contracts? If so, please provide details & any associated documentation from completed market engagement, or advise on anticipated timelines for future IUC market engagement.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

ICB wide response for NHS111 and Clinical Assessment Services

1. The service provider is:
 - a. North East Ambulance Service NHS Foundation Trust (NEAS) provides NHS 111 services.
 - b. NEAS provides the clinical assessment service.
2. Contract start dates for NHS 111 and CAS were 1 October 2025.
3. Both NHS111 and CAS contracts are 3 years with the option to extend for a further 2 years.
4. The NHS111 and CAS contracts with NEAS are due to expire on 30 September 2028 (extension to 30 September 2030).
5. NHS111 and CAS is a joint contract. The annual contract value is £15,307,000.
6. NENC ICB does not have an anticipated timeline for the procurement of future NHS111 and CAS contracts.
7. It is unknown at this time whether the ICB will commission future IUC service components separately or together.
8. NENC ICB does not intend to introduce additional services or expand the scope of NHS 111 and CAS.
9. AI triage is not used within NHS111 and CAS.
10. We cannot confirm at this time whether for future IUC procurements, the ICB will mandate AI triage.
11. No, NENC ICB cannot confirm at this time which procurement process will be used for future IUC procurements.
12. The ICB has not conducted or intend to conduct any market engagement at this time for NHS111 and CAS.
