## Freedom of Information Act 2000 - Request for Information – NHS North East & North Cumbria Integrated Care Board.

Thank you for your request received by North of England Commissioning Support (NECS) on 14 June 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (NENC ICB). NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows;

ICB Place	Number of GP practices	Number that currently offer specialist menopause services
County Durham	61	Information not held – you would need to contact the practices to ask if they provide these services
Newcastle	29	None are specifically contracted to offer specialised menopause services. Practices may offer more but you would need to contact the practices to ask if they provide these services.
Gateshead	25	We don't commission specialist menopause services; you would need to contact the practices to ask if they provide these services.
Northumberland	36	As we do not commission any additional service for specialist menopause, some practices may provide different levels of service - this is not information we hold within North Cumbria. You would need to contact the practices to ask if they provide these services.
North Cumbria	34	As we do not commission any additional service for specialist menopause, some practices may provide different levels of service - this is not information we hold within Northumberland. You would need to contact the practices to ask if they provide these services.
North Tyneside	24	Nil under contract. Some practices may provide different levels of service, but this is not information we hold within the ICB. You would need to contact the practices to ask if they provide these services.
South Tyneside	21	Nil under contract. Some practices may provide different levels of service, but this is not information we hold within the ICB. You would need to contact the practices to ask if they provide these services.
Sunderland	38	Nil under contract. Some practices may provide different levels of service, but this is not information we hold within the ICB. You would need to contact the practices to ask if they provide these services.
Tees Valley	78	No specialist menopause services commissioned by GP practices in Tees Valley however you would need to contact the practices for any further information.
