# <u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 04/01/2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

## Request

Dear NHS North East and North Cumbria Integrated Care Board Freedom of Information Team

I am writing to make a request under the Freedom of Information Act 2000. Please could you provide me with the information requested below.

For each of the Mental Health Support Teams that are (a) operational within the NHS North East and North Cumbria Integrated Care Board area or (b) will become operational by the end of 2024, please provide the following information:

- 1. The name of the MHST
- 2. The town/city in which the MHST is based
- 3. The number of: (a) secondary schools, (b) primary schools (including infant and junior schools), (c) sixth-form colleges or FE colleges, and (d) other education settings that are assigned to the MHST
- 4. The total approximate number of pupils attending the education settings assigned to the MHST
- 5. The financial year in which the MHST became, or will become, operational
- 6. The approximate annual budget of the MHST in the 2022/23 financial year
- 7. The number of full-time equivalent clinical staff assigned to the MHST
- 8. The number of full-time equivalent non-clinical staff assigned to the MHST
- 9. The estimated number of children who participated in any one-to-one interventions provided by the MHST in the 2021/22 financial year
- 10. The estimated number of children who participated in any small group interventions provided by the MHST in the 2021/22 financial year.
