## Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 24 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

## **Your Request**

I would be most grateful if you would provide me, under the Freedom of Information Act, details in respect to the contract below. The details we require are:

- 1. Have you in the last 12 months contracted with an independent provider to provide community diagnostics, including mobile diagnostic solutions?
- 2. Do you have an independent provider on patch for community diagnostics?
- 3. If so, who are the providers and which areas of the ICB do they cover?
- 4. Which diagnostic services went through procurement, and which were a direct award?
- 5. Actual spend on each contract/framework (and any sub lots), from the start of the contract to the current date and annually.
- 6. Start date & duration of framework/contract/award?
- 7. Diagnostic contract due to expire in next 24months, if so which provider and value of contract?
- 8. Could you please provide a copy of the service/product specification given to all bidders for when this contract was last advertised?

- 9. Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?
- 10. Has a decision been made yet on whether the framework(s)/contract(s) are being either extended or renewed?
- 11. Who is the senior officer (outside of procurement) responsible for this/these contract/s?

## **Our Response**

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by the acute hospital NHS foundation trusts (FTs) within the North East and North Cumbria region.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those acute hospitals to make your request.
