## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 17 May 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

## Your Request

I am writing to you under the Freedom of Information Act 2000 to request the following information. Please may you provide me with the following data for your NHS ICB for the last 5 years:

- 1. Number of pathology laboratory test referrals per trust for your constituent trusts
- 2. Number of pathology laboratory test referrals completed electronically per trust (i.e., not through paper referral form)
- 3. Number of pathology laboratory testing requests (no. of transactions) per trust
- 4. Number of pathology lab sites under each of your trusts
- 5. The LIMS system currently used by your different trusts
- 6. Number of pathology laboratories you refer pathology tests/requests to
