**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 26 February 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

The questions we would like to ask other Trusts that provide continence products to adults in community (ie own homes or care homes/residential care) are as follows:

1. Do you provide continence products to adults?
2. If so, what is your continence budget?
3. If so, are there any exclusions e.g. nursing homes?
4. Is you spending in line with the allocated budget (are you underspending or overspending?)
5. What is your continence budget per head of population (over 18)?
6. Do you have a minimum pad requirement and a limit on the maximum number of pads provided per individual per day?
7. Do you have any information about delivery charges/costs to patients own homes and nursing homes?
8. What product brands do you use?
9. Do you have any schemes or pathways that have successfully reduced the requirement for continence products, or reduced the cost of continence product provision? Or delivery charges? Could you detail these?

10. Do you have a specialist continence service or do your district nurses provide continence products?

## **Our Response**

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.
