**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 19 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

Under the Freedom of Information Act, I would like to request the following information, included in the attachments:

1. FOI – ICB AACC – Finance & Data Reporting
2. FOI – ICB AACC – Service Delivery

Please consider that you may need to complete more than one response, if you have different providers/models/geographies (e.g., partially in-house, with some elements provided by another provider, or some elements may be done by a local authority, etc). Could you also please ensure that you share the context of the request, with whoever you forward this on to, for completion?

*To clarify:*

In most ICBs the terminology of an 'end to end' service includes Continuing Healthcare, Funded Nursing Care, Fast Track, Children and Young Peoples Continuing Care.

Some ICBs may also include joint funding. Some ICBs may include Complex care but there may be different interpretations to what 'complex care' means; therefore, for example one ICB may

consider 'looked after children' cases or 'cases that do not meet the eligibility criteria for NHS CHC/CYP eligibility are defined as 'complex cases' and another ICB may consider some MH/LD cases not eligible for CHC or S117 funding as 'complex cases'.

Therefore, please can you provide information in relation to any case activity/cohorts of cases the ICB may currently include in the AACC activity national reporting and AACC financial national reporting that the ICB considers is included in the AACC end to end service provision.

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested. This is detailed on the attached documents.
