**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 22 May 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

Under the Freedom of Information Act 2000, please could you provide the following information:

- The name and contact e-mail address of the person responsible for Women's Health.
- Whether your ICB funds a menopause specialist clinic in your area.
- Whether your ICB funds menopause clinics in Primary Care.

**Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

- The responsible person for Women's Health is Siobhan Brown, Director for Healthier Fairer, Women's Health and Project Management Office, contact email, [siobhan.brown3@nhs.net](mailto:siobhan.brown3@nhs.net)

- Funding has been awarded to develop Women's Health Hubs in Sunderland, Gateshead and North Cumbria (which technically represents the specialist clinic element). NHS Menopause clinics have also been funded in Newcastle, Durham and Darlington.
- In primary care, a small number of menopause clinics are funded (using extended access funding) across the ICB footprint, including Hartlepool.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website <https://northeastnorthcumbria.nhs.uk/>.
