Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 9 October 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to request information under the Freedom of Information Act 2000 regarding the procurement of uniforms and linen by your organisation. Specifically, I would like to obtain the following details:

- 1. Current supplier(s) for uniforms and linen.
- 2. Contract end date and any known renewal or retender schedule.
- 3. Annual usage in quantity (e.g., pieces or sets) for each product category tentative
- 4. Annual spend amount on uniforms and linen over the past 12 months.
- 5. Any measurable social value commitments linked to the contract, such as local employment initiatives, skills development, or community benefits.
- 6. Any reported carbon reduction outcomes related to the supply or logistics of uniforms and linen.
- 7. Any sustainability metrics tracked, including material composition, recycling/repurposing initiatives, or environmental impact assessments.
- 8. Whether SME suppliers are considered or encouraged for participation in future procurement exercises for uniforms and linen
