Thank you for your request received on 14 April 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

I am writing to you under the Freedom of Information Act 2000 to request the following information from the North East and North Cumbria Integrated Care Board.

- 1. How many new and re-referred patients requested a temporary and/or permanent wheelchair after assessment in 2025, 2024, 2023, 2022, 2021 and 2020?
- 2. What is the expenditure on wheelchairs for new and re-referred patients annually? Please could you send through figures from 2025 so far, 2024, 2023, 2022, 2021 and 2020.
- 3. What is the average waiting time for a home patient who needs a wheelchair? Please could you send through figures from 2025 so far, 2024, 2023, 2022, 2021 and 2020.
- 4. What type of wheelchairs do you offer to new and re-referred patients?

Please could the data sent over be broken down into areas.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under the Section 16 obligations of the Act, as to how I can refine my request.
