## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and</u> <u>North Cumbria Integrated Care Board</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 27 January 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria ICB. This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

## **Details of Request**

Please can you provide under the Freedom of Information Act a structure chart for the Trust, inclusive of all Human resources 'Heads of Service,' 'Assistant Directors' and Directors with the full job titles and the names of individuals who hold these positions.
