Thank you for your request received by North of England Commissioning Support (NECS) on 28 February 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up - Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.


Your Request and our Response

Please answer:

- 1. Does your organisation have any ongoing so-called "block bookings/contracted beds" for care provision with the following private care companies:
 - a. Malhotra Care Homes Limited
 - b. Prestwick Care Limited
 - c. Lifestyle Care (North East) Opco Limited
 - d. Malhotra Care Homes (Sunderland) Limited
- 2. If so, how many beds are booked? Please provide details per care home where possible.
 - E.g. 50 beds contracted in Addison Court care home.
- 3. How much do you pay for any block bookings/contracted beds with these companies. Please list the amount per provider and the total cost of the contract where possible.

Responses to Questions 1-3

The ICB does not hold any contracts with the providers listed for 'block bookings' of beds. The ICB does have access to block booked beds commissioned by relevant local authorities at the following homes:

- 8 block funded beds at Parklands Nursing Home in Seaham, funded and contracted by Durham County Council
- 20 block funded beds at Eastside Gardens Care Home, funded by the Adult Social Care discharge fund and contracted by North Tyneside Council
- 3 block funded beds at Brooke House, 3 at Belle Vue and 1 at Brunswick House. These are all contracted by Newcastle City Council

We understand that Local Authorities have received the same FOI and therefore expect that they will provide further details on the above arrangements as the contracting authority as they hold this information, rather than the ICB, however the relevant Local Authority contact details have also been provided below.

Are you reviewing your arrangement with any of these providers following revelations in a recent BBC Panorama investigation that staff are overworked, feel trapped by their contracts, and Addison Court care home (run by Prestwick Care) had its rating suspended by the CQC? Please provide details per provider.
