# <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 23 June 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

### **Your Request**

Could we have all the area prescribing committee ICB minutes from the North East and Cumbria that mention Inclineran.

#### **Our Response**

Northern Treatment Advisory Group (NTAG) and North East North Cumbria ICB Medicines Committee are currently the decision making groups.

NTAG discussed inclisiran in September 2022 <u>NTAG-Minutes-September-2022.pdf</u>. Medicines Committee have not discussed Inclisiran since it was set up in September 2022.

Previous to that point three Area Prescribing Committees managed formularies and medicines guidelines.
