<u>Freedom of Information Act 2000 – Request for Information – NHS North East and</u> <u>North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 24 November 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act 2000 I would like to request the following information.

The amount spent by the North East and North Cumbria Integrated Care Board (or the equivalent organisation) on taxis for NHS patients over the last five calendar years (broken down by year, 2023, 2022, 2021, 2020, 2019).

Our Response

This response covers North East and North Cumbria Integrated Care Board (ICB) and former Clinical Commissioning Groups (CCGs) in the North East and Cumbria area for financial years 2019/20 to 2022/23.

The figures below show spend identified in the ledger/s with taxi providers or providers where the service being billed was for taxi services for a patient.

If providers have billed for patient journeys via taxi but have submitted their invoices without a description of 'taxi' and if their name doesn't include 'taxi', the costs will not have been included within the figures.
