Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 22 August 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

- 1. Which NHS organisations or Local Authorities within your region are currently providing Child **Obesity Clinics?**
- 2. Does the region have plans to introduce new Child Obesity Clinics?
 - a. If so, please provide an estimated timescale.
 - b. If so, in which NHS organisations or Local Authorities will these Clinics reside?
- 3. The name of the person within the ICS, NHS organisation or Local Authority who is responsible for managing Child Obesity Clinics. Please provide a contact email address if possible.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

- 1. Within the North East and North Cumbria, the following acute hospital foundation trusts (FTs) are currently providing Child Obesity Clinics:
 - South Tees Hospitals NHS FT (part of NHS England national pilot)
 - The Newcastle upon Tyne Hospitals NHS FT (part of NHS England national pilot)

- County Durham and Darlington NHS FT (existing commissioned service).
- 2. No, the region has no plans to introduce new clinics. The NENC ICB Clinical Conditions Strategic Plan highlights childhood obesity as a priority along 5 key recommendations. In relation to Child Obesity Clinics, "We will ensure that the tertiary centres are sustainable in the long term for regional referrals, advice and shared care."
- 3. The North East and North Cumbria Child Health and Wellbeing Network provide oversight for the pilot sites in South Tees and Newcastle. The service in County Durham and Darlington is a shared responsibility across the ICB.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website https://northeastnorthcumbria.nhs.uk/.
