# Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 8 November 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

### **Your Request**

I am writing to you under the Freedom of Information Act 2000 to request the following information from your Trust. Please may you provide answers to the following:

#### 1. Population and budget allocation

Please provide the current estimated number of people within your ICB diagnosed with each of the following long-term conditions:


- a. Obesity

Please provide details of any services supporting integrated care pathways for multiple longterm conditions, specifically targeting obesity, diabetes, chronic kidney disease, cardiovascular disease, and liver disease.

2. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information.
