Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 6 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am making a FOI request relating to alopecia and the drug Ritlecitinib.

I am aware there have been funding issues at Newcastle upon Tyne Hospitals NHS Foundation Trust which has delayed the implementation and roll out of this medicine for patients who qualify for Ritlecitinib and who are in desperate need of this NICE approved drug.

I was hoping you could provide me with an update as to when we will be able to access this drug in the North East. I am keen to understand when we will catch up to the rest of the UK and what the delays have been.

Here are the details of NICE's approval and implementation plan, dated 27th March 2024 and as you will see local authorities are to comply with the recommendations in this evaluation within 3 months of its date of publication. https://www.nice.org.uk/guidance/ta958/chapter/4-**Implementation**

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

The ethical decision-making group is passing its recommendation to the North East and North Cumbria Clinical Effectiveness and Governance Subcommittee for consideration in February 2025, which will then be considered by the North East and North Cumbria Integrated Care Executive Committee. Therefore, it is likely that the decision will not be made until March 2025.

The March 2025 Public Executive Committee meeting minutes will be uploaded to the website with the next set of Board papers which will be for 3 June 2025, meeting so the papers will be uploaded around 27 May 2025.
