About this information pack

This common conditions campaign toolkit is for GP practices.

The campaign aims to encourage the public to <u>'think pharmacy first'</u> for a range of minor conditions which community pharmacies can advise and treat under the common conditions scheme. This scheme is currently provided in almost all pharmacies across the North East and North Cumbria.

What is the 'think pharmacy first' common conditions scheme?

As you may be aware the scheme encourages people to consider seeking advice and/or medicines from a local community pharmacy for a range of common conditions before contacting their GP practice or going to another healthcare setting such as an urgent treatment centre.

Who can use the common conditions scheme?

Anyone. The service is available for all adults and children, across the North East and North Cumbria, but aims to target those who would normally access a GP, urgent care centre or accident and emergency department for certain common conditions. The service is available at most pharmacies in the region.

People who receive free prescriptions, or hold a valid medical exemption certificate, may not need to pay for some over the counter (OTC) medicines without the need to see their GP.

People can go straight to a participating pharmacy themselves (you don't need to be referred) or they may be signposted to the service by their GP practice and/or NHS 111.

What sorts of conditions does the scheme cover?

Conditions that can be treated at a local pharmacy include:

- Sinusitis (12 years +)
- Sore throat (5 years +)
- Earache in children (1-17 years)
- Infected insect bites (1 year +)
- Impetigo (1 year +)
- Shingles (18 years +)
- Uncomplicated urinary tract infections (UTIs) in women (16-64 years)



Specified conditions - Patients with symptoms associated with the following specified conditions may self-refer into this service and present to any participating pharmacy.

Communication resources to support people working in GP practices

Having conversations

Please support this "think pharmacy first" common conditions campaign by briefing all patient facing colleagues, who may be able to signpost patients towards their local community pharmacy, where appropriate.

When a patient presents with a common condition or symptoms, listed in the specified conditions above, please refer them to their local community pharmacy for further advice and/or over the counter medication.

If a patient is seen with a common condition, and can be referred to a community pharmacy, please use the treatment recommendation pad, supplied in this toolkit, to write the product name you recommend them to purchase. The patient can then hand this to the community pharmacist to assist them in purchasing the correct treatment if necessary.

Please highlight to patients the benefits of visiting a community pharmacy for advice and/or medication. For example:

- No appointment necessary
- Confidential consultation space available if needed
- Fully qualified pharmacists are health care professionals and can advise and provide medication for common conditions over the counter where appropriate
- Patients who normally receive free prescriptions or hold a valid exemption certificate, may not need to pay for some over the counter medicines



Information for websites

Got an...itch, tummy trouble, tickly cough head to your local pharmacy!

Pharmacies across the North East and North Cumbria can offer advice and treatment for many common health conditions. There's no need for a GP appointment – just head to your local pharmacy.

Pharmacists are qualified experts in healthcare and can help with a wide range of common illnesses.

Who can use this service?

Anyone. The service is available for all adults and children, in participating pharmacies, across the North East and North Cumbria.

Why should I go to a pharmacy, instead of my GP practice?

Local community pharmacists are trained to treat common conditions. They offer a confidential and high-quality service designed to meet your needs. You can walk in with no appointment needed and speak in confidence. Most pharmacies have private consultation rooms available.

Which pharmacy can I go to?

Most pharmacies across the North East and North Cumbria offer the common conditions service. Ask your local pharmacy for more details.

What will the pharmacist ask me?

The pharmacist will ask you questions about:

- your symptoms
- your current medication
- history of ailments
- any other illness you have

The answers will help the pharmacist to advise and treat your condition.



Will I always get treatment for my condition?

You will be given treatment if necessary.

Your pharmacist may decide that you need further advice/treatment and can signpost you to another service or contact your GP practice directly, to book you an appointment.

IMPORTANT INFORMATION Your pharmacist will provide treatment and/or advice under the common health conditions scheme, in line with the symptoms you have described. If your symptoms persist, you should seek further advice from your GP.

How it works

Step 1 – Pop along to your local pharmacy and talk to a health care professional about your illness and they will offer advice.

Step 2 - If you need treatment, the pharmacist will check your eligibility and whether the illness is covered by the service

Step 3 - A suitable medicine may be offered to you*

Charges will apply if you normally pay for your prescriptions.

If you hold a medical exemption certificate, for example people under 16 or over 60, then you will not pay for your medicine.

What health conditions are covered as part of this service?

Under the 'Pharmacy First' scheme, pharmacists are able to prescribe NHS medications, including antibiotics and antivirals, for certain conditions, where clinically appropriate, for a range of minor health conditions, without the need to see a GP.

Conditions that can be treated at a local pharmacy include:

- Sinusitis (12 years +)
- Sore throat (5 years +)
- Earache in children (1-17 years)
- Infected insect bites (1 year +)
- Impetigo (1 year +)
- Shingles (18 years +)
- Uncomplicated urinary tract infections (UTIs) in women (16-64 years)



The ICB minor illness service also covers advice and treatment for:

- Aches and pains back pain, headache, migraine, muscle ache, period pain, teething, toothache
- Allergies bites and stings, hay fever, skin reaction
- Colds and flu cough, congestion, sore throat, fever / temperature (including fever following immunisation)
- Ear care earache, ear infection, ear wax
- Eye care bacterial conjunctivitis, styes
- Gastrointestinal care diarrhoea, constipation, indigestion, haemorrhoids (piles), reflux, threadworms, sickness
- Head lice
- Mouth care cold sores, oral thrush, ulcers
- Skin care athletes foot, chicken pox, contact dermatitis / atopic eczema, fungal skin infections, nappy rash, pruritis, scabies, warts, verrucaes
- Vaginal thrush
