#### <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received on 22 May 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

# Your Request

I was informed by my GP surgery last year that the ICB is commissioning a central service for shared care agreements for patients with Adult ADHD diagnoses and prescriptions from a private provider. I am unable to find any information on this and have previously contact the ICB to request such.

Please can you let me know the status of this service and how to access it. Alternatively, please can you put me in contact with someone who can discuss this matter.

# **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

We can confirm that NENC ICB are not looking to commission a central service for shared care agreements for patients with Adult ADHD diagnoses and prescriptions from a private provider.

We recognise there are challenges for patients accessing NHS prescriptions for ADHD medication through shared care, in relation to ADHD medication, where a formal diagnosis of ADHD has been

offered by a private provider including those providing diagnostic assessments under NHS Right to Choose.

Individual GP Practices can decide whether they are willing to enter into a shared care arrangement with a Provider, either an NHS Trust or the 'right to choose' providers, or not. For ADHD, this relates to prescribing and monitoring medication. GP Practices do not have to agree to shared care for new patients, and practices do not have to indefinitely continue to prescribe for current shared care patients.

As an ICB we have established a formal group to look at improving all aspects of the diagnostic pathway wherever this is practicable, within the current national guidance, contractual frameworks and available resource.
