## Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 8 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

Under the Freedom of Information Act, I would like to request the following information around the ICBs eye care commissioning:

- 1. Any services commissioned by the ICB over and above the core GOS sight test, whether that be from primary care optometrists, community services that are not delivered from optometry practices or acute care outside of the core acute contract.
- 2. The contract start date and duration of any such services.
- 3. The number of patients seen in those services over the last full reported year or part year if commencement has been in 2024/25.


## **Our Response**
