# <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 10 January 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

### **Your Request**

Under the Freedom of Information Act, I would like to Request the following information:

What is the total cost for all translation and interpretation activities for each of the financial years 21/22 and 22/23. I would like a separate total for each financial year.

#### Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

#### Primary Care Interpretation Services Spend

This covers North East and North Cumbria ICB. The ICB have only held the Primary care Interpretation services contract since April 2023, prior to the ICB holding it, it was with

NHS England North East & Yorkshire region and the ICB do not hold the information for the period before the 1st April 2023.

The North East and North Cumbria Integrated Care Board (NENC ICB) does not hold all the records which you have sought. However, we have determined the records are held by NHS England.
